



Composition of Students' Grievance Redressal Committee (SGRC)

Students' Grievance Redressal Cell (SGRC) has been constituted comprising of the following:

The term of the Convenor and members shall be for a period of two years and the term of the special invitee shall be one year.

The quorum for the meeting including the Convenor, but excluding the special invitee, shall be three.

A complaint from an aggrieved student relating to the institution shall be addressed to the Convenor, SGRC.

In considering the grievances before it, SGRC shall follow principles of natural justice.

The SGRC shall send its report with recommendations, if any, to the competentauthority of the institution concerned and a copy thereof to the aggrieved student thereof to the aggrieved student, preferably within a period of 15 working days from receipt of the complaint.
