Now this MOU witness and it is agreed by and between the parties as follows:

- 1) A written request for OPD should be made by B.N.M College, Barhiya, Lakhisarai. This request will be either faxed/e-mailed or hand delivered by the beneficiary and produced at the time of admission along with photo identity proof issued from Badri Narayan Mukteshwar College, Barhiya, Lakhisarai, Bihar.
